### BOARDING AGREEMENT

Payment shall be \$25 per day. There are no exclusions to this rate (i.e. horseshows). A 7.5% late payment charge will apply if not paid by the 5th of each month. Boarding fees include feed (not including alfalfa or supplements), bedding, turnout, and blanketing. Additional services (e.g. shots, clipping, grooming) will be at the Service Fee Rate.

Payment for each month of board is due in advance. Services performed, to include farrier and vet charges, must be paid upon invoice. All payments must be complete before horse is moved from farm.

#### Boarding Stipulations

1. Craig Thompson Eventing, its owners and all employees assume no responsibility for any accident, injury, or death to horse, pony or boarder.
2. Craig Thompson Eventing, its owners, and all employees assume no responsibility for total loss and/or damage to any personal tack, equipment or property. Leave at your own risk.
3. Boarder agrees to assume full responsibility for all of boarder's guests and boarder's and guest's personal property. Boarder agrees to have all persons who ride boarder's horse(s) sign a release form first.
4. In case of emergency, authorized stable personnel have the right to call in a vet, at the owner's expense.
5. All horses must be under Craig Thompson Eventing's shot program while boarded. Worming is the responsibility of the horse owner. Worming needs to be done at least every 60 days.
6. Boarder authorizes Craig Thompson Eventing to arrange for routine shoeing and medical examination and treatment of boarder's horse(s). Craig Thompson Eventing shall make reasonable efforts to contact and consult boarder regarding any emergency medical treatment.

7. A current (within 12 months) negative coggins test must be on file.
8. 30-day notice must be given prior to termination of this agreement.
9. Craig Thompson Eventing reserves the right to terminate this agreement upon 30-day notice.
10. No smoking is allowed around the barns or arenas.
11. Dogs may be allowed with permission only.
12. An approved hard hat and boots must be worn while riding on the farm property.
13. For safety reasons, boarders are not permitted to use jumps without Craig's permission.
14. Craig Thompson Eventing agrees to provide hay and grain for events, but bedding for trailers or stalls is the responsibility of boarder.
15. Two supplements can be fed by staff. For more supplements, boarder agrees to provide SmartPaks.
16. Rates are subject to change with 30-day notice.
17. Other services (such as grooming, icing, and handwalking) are available for a fee.
18. Boarders are required to take a minimum of 2 lessons per week.
